COOKIES POLICY

What are cookies?

Cookies are small data files that are received in the terminal from the visited website and are used to record certain browsing interactions on a website storing data that can be updated and retrieved. These files are stores on the user's computer and contain anonymous data that is not harmful to your computer. They are used to remember user preferences, such as the selected language, access data or personalization of the page.

Cookies can also be used to record anonymous information about how a visitor uses a site. For example, from which Web page you have accessed, or if you have used an advertising banner to get there.

What use do we give to different types of cookies?

According to its purpose:

Technical cookies	Technical cookies are those that facilitate user navigation and the use of the different options or services offered by the web such as identifying the session, allowing access to certain areas, facilitating orders, purchases, filling in forms, registrations, security, facilitate functionalities (videos, social networks).	
Personalization cookies	Personalization cookies allow the user to access the services according to their preferences (language, browser, configuration).	
Analytical cookies	The analysis cookies are those used to carry out the anonymous analysis of the behaviou of the users of the web and that allow to measure the activity of the user and to elaborate navigation profiles in order to improve the websites.	
Advertising cookies	Advertising cookies allow the management of the advertising spaces of the web. In addition, these cookies can be personalized advertising and thus allow the management of the	

advertising spaces of the web based on the behaviour and habits of user navigation, where your profile is obtained and allow you to customize the advertising shown in the

browse of the user or other profiles and social networks of the user.

According to its term:

Session cookies	Session cookies are those that last as long as the user is browsing the website and are deleted when the browser is closed.
Persistent cookies	These cookies are stored in the user's terminal until they are manually deleted, or the period of duration established for said cookie has ended.

According to its ownership:

Own cookies	Those that are sent to the user' terminal equipment from a computer or domain managed by the editor itself and from which the service requested by the user is provided.
Third-party cookies	Those that are sent to the user's terminal equipment from a computer or domain that is not managed by the editor, but by another entity that processes the data obtained through cookies.
